Driver agreement:

You understand that the California Child Passenger Safety Law (VC 27350 and 27360.5) requires that all children must have their own seat belt and proper safety car seat and may not be placed in a front seat protected by an air bag. **You will ensure that all children will be properly secured in an appropriate child passenger restraint or booster seat in the back seat of the vehicle until they are at least 8 years old or 4' 9" in height.** Children must be placed in appropriate child restraint car seats and you agree to ensure the car seats don't move more than one inch to the side or the front of the car. You will also not allow any child less than 13 years of age to ride in the front seat at anytime.
