Kinder Prep: Full Day or Half Day – both are 5 day (M – F)

Additional charges: Non-refundable application fee of \$75 for each new student and Non-refundable yearly Registration Fee \$750 grades K – 8, and \$600 for Pre-school and Kinder Prep. I-20 students will be charged a yearly processing fee of \$100. Changes to enrollment status – withdrawal or changing Preschool and Kinder Prep options- incur a \$50 per child fee. Fourth child is 90% of the third child tuition.

*REGISTERED PARISHIONER RATE

**A Registered Parishioner is a parishioner registered with a Catholic parish and meets the requirement of stewardship (time, talent & treasure) as defined by the pastor. A letter from the Pastor of your Catholic parish, stating that you are registered and meet the requirements of stewardship, will be required each year to receive the registered parishioner enrollment rate.*

**Eighth Grade Graduation Fees of \$375 will be billed with tuition

TUITION PAYMENT OPTIONS:

All families are expected to make tuition payments according to one of the following payment options.

Please check **one** plan from the selections below: (All payments are made through FACTS)

- OPTION #1: ANNUAL (SINGLE) PAYMENT THIS OPTION IS REQUIRED FOR I-20 STUDENTS**
 - Full payment due on or before July 1, 2022 by ACH or Credit Cards
 - Credit card processing fee 2.85%; no FACTS fee
- OPTION # 2: SEMI-ANNUAL PAYMENT: FACTS FEE OF APPROXIMATELY \$10**
 - 1st payment due on or before July 1, 2022; Credit Cards or ACH accepted
 - 2nd payment due on or before January 1, 2023; Credit Cards or ACH accepted
 - FACTS fee \$20; Credit card processing fee 2.85%
- OPTION # 3: 10 MONTH PAYMENT:**
 - Tuition is paid over a 9 month period using FACTS. If you choose this option FACTS will charge an annual management fee of approximately \$45.00. The 10 month payment plan begins July 1, 2022 with **two (2) months payments** and then one monthly payment due the first of each month August 2022 – March 2023. The FACTS payments can be made by ACH or credit card with a choice of paying on either the 5th or the 20th of the month. Credit card processing fee of 2.85% applies.
